Objet : OIAC / Forum en ligne sur les utilisations pacifiques de la chimie (27 avril 2022)

J'ai l'honneur de porter à votre connaissance que le Secrétariat Technique (ST) de l'Organisation pour l'Interdiction des Armes Chimiques (OIAC) invite les Etats parties à désigner des candidats pour prendre part à un **Forum en ligne sur les utilisations pacifiques de la chimie**, prévu, le 27 avril 2022. Ce Forum vise la sensibilisation et le renforcement des connaissances en ce qui concerne la gestion de la sûreté et sécurité chimiques et ce, en mettant l'accent sur la promotion de la sécurité chimique et les bonnes pratiques qui s'y rapportent.

L'objectif général de ce Forum est de partager les meilleures pratiques et les leçons acquises dans le cadre de la gestion de la sécurité chimique, ainsi que les politiques adoptées par les Etats Parties en vue de favoriser la coopération Internationale à ce propos. Le Forum vise également la sensibilisation au sujet du renforcement des capacités en matière de sécurité chimique pour les générations futures.

Dans ce sillage, le ST de l'OIAC a précisé que ce Forum est destiné aux chimistes, ingénieurs chimiques et autres professionnels gouvernementaux concernés ainsi qu'aux représentants d'universités et de l'industrie ayant des responsabilités liées à la mise en œuvre de la Convention sur l'Interdiction des Armes Chimiques. Les candidats proposés doivent avoir une **bonne maîtrise de l'anglais** à l'oral comme à l'écrit (*langue de déroulement du Forum, traduction non prévue*).

Il y a lieu de souligner que la partie organisatrice invite les candidats proposés, à s'inscrire, **avant le 18 mars 2022**, sur le système de gestion d'événements « **Eventus** » de l'OIAC, accessible à l'adresse électronique suivante :

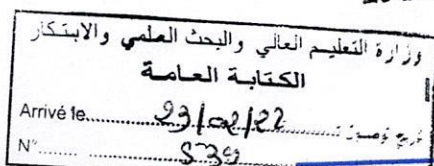

NOTE BY THE TECHNICAL SECRETARIAT**ONLINE FORUM ON THE PEACEFUL USES OF CHEMISTRY
27 APRIL 2022****Purpose of the forum**

1. The Technical Secretariat of the Organisation for the Prohibition of Chemical Weapons (hereinafter "the Secretariat") wishes to inform Member States that it is organising an online forum on the peaceful uses of chemistry, which is aimed at raising awareness and enhancing knowledge and understanding on chemical safety and security management, with a particular focus on advancing chemical security and related best practices. The forum will take place on 27 April 2022.
2. The forum is intended for chemists, chemical engineers, and other relevant professionals from government and international and regional organisations, as well as representatives from academia and industry with leadership responsibilities related to the implementation of the Chemical Weapons Convention (hereinafter "the Convention").
3. The overall objective of the forum is to create a platform for sharing lessons learned and best practices in chemical security management, in addition to learning about the policies adopted by Member States to foster international cooperation for chemical security management. The forum is also aimed at raising awareness of chemical security capacity-building programmes for future generations.
4. The forum will accommodate 60 participants from Member States whose economies are either developing or in transition.

Basic structure of the forum

5. The forum will begin with an introduction to the Convention and its relevance to chemical safety and security. It will include a discussion on lessons learned and best practices in chemical security management and touch upon international cooperation efforts in the field of chemical activities for purposes not prohibited under the Convention.

Eligibility requirements and selection procedure

6. Applications will be carefully screened based on the criteria specified in paragraph 2 above. Only selected participants will be contacted by the Secretariat.

7. All forum activities will be conducted in English, and no interpretation services of any kind will be provided. Participants are therefore expected to have a good command of the English language, both written and oral.
8. Nominations of female candidates are strongly encouraged.

Application procedure

9. Interested candidates are invited to submit their applications through Eventus, the OPCW event management system (<https://apps.opcw.org/eventus>). Applicants must first create an account and then register for the event. Only applicants who, for technical reasons, are unable to submit their applications online via Eventus are requested to complete and send the endorsement and application forms (attached as Annexes 1 and 2 to this Note) as an email attachment (icb.events@opcw.org), with the reference "Online Forum on Peaceful Uses of Chemistry" in the subject line of the message.
10. Only nominations endorsed by the National Authority or Permanent Representation of the applicant's country to the OPCW will be considered. The endorsement form (Annex 1), together with an up-to-date curriculum vitae, must be uploaded when submitting applications online.
11. Completed applications should be submitted to the Secretariat **no later than Friday, 18 March 2022**.
